## **Ending Hunger Campaign**

Maine Credit Unions' Campaign for Ending Hunger raised approximately \$740,000 this year, thanks to the generosity of members like ours, who participate in so many events throughout the year to help raise funds. The Campaign began 28 years ago and has grown to be one of the largest non-hunger organizations, coordinated fundraising efforts in the state. Devon Harris, three-time Olympian with the Jamaican bobsled team and the inspiration for the Disney blockbuster movie, *Cool Runnings*, was the keynote speaker and announced how successful the campaign had been this year.

Harris, who formed a foundation in 2006 which includes helping make sure children have enough to eat so they can do better in school, said, "You are providing hope to kids I was once like. Empty cupboard, no food, been there done that. The help that the credit unions in Maine are giving to kids and adults, in general, through your Campaign is amazing. You have found a cause and you are making a difference in the lives of the people in your state. What I would say to you in

closing, though, is don't stop now— the need remains and people need the hope that having enough to eat provides."

Todd Mason, President of the Maine Credit Union League, said, "The Campaign's success highlights the strength of Maine's credit unions and underscores how special the Maine credit union system is. We are doing great things in our state so we should all feel proud of receiving recognition for a Campaign that is a model for how cooperation can bring about good things and make a difference."

# ATTENTION: IRA Owners with Required Minimum Distributions Witholding Notice

Payments from your IRA are subject to federal income tax withholding, unless you elect no withholding.

You may change your withholding election at any time prior to receipt of a payment. To change your withholding election, complete the appropriate form available at your credit union.

Withholding from IRA payments, when combined with other withholding, MAY relieve payment of estimated income taxes. However, withholding election does not affect the amount of income tax you pay.

You may incur penalties under the estimated tax rules if withholding and estimated tax payments are insufficient.
